**SECTION 3:** Appropriation Ordinances No. 163-16 previously adopted by the Mayor and City Council of the City of Union City is hereby amended.



**SECTION 5:** This ordinance shall take effect ten (10) days from and after its passage on second and final reading and after publication in the official city newspaper.


