

ORDINANCE NO 246-23

AN APPROPRIATIONS ORDINANCE FOR THE CITY OF UNION CITY, TENNESSEE, FOR FISCAL YEAR BEGINNING JULY 1, 2022 AND ENDING JUNE 30, 2023

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF UNION CITY, THAT:

SECTION 1. The following appropriations for the fiscal year beginning July 1, 2022, and ending June 30, 2023, be and the same are hereby made for the operation of the several departments of the City of Union City, Tennessee, by funds as follows:

SECTION 5. This Ordinance shall take effect July 1, 2023.
