When granting a variance, the Board must:

- A). Make a finding that the reasons set forth in this application justify granting a variance, and that the variance is the minimum variance that will make possible the reasonable use of the land, building or structure: and
- B). Make a finding that the granting of the variance will be in harmony with the general purpose and intent of this ordinance, and will not be injurious to the neighborhood, or otherwise detrimental to the public welfare.

In the following parts of this application, you are to demonstrate how your request for a variance meets each of the listed conditions for granting a variance.

1. Demonstrate that conditions and circumstances exist which are peculiar to your property, which are not applicable to other properties in the same district:

2. Demonstrate that literal interpretation of the provisions of this ordinance would deprive the applicant of rights commonly enjoyed by other properties in the same district under the terms of this ordinance:

4. Demonstrate that granting this variance will not confer on you any special privilege that is denied by this ordinance to other properties in the same district.
